Read the following conditions below from Sahuarita Town Code Chapter 18.79, Sign Standards. Sign your name in the space provided indicating you agree to follow all of the conditions below as well as any additional regulations for the specific sign type as provided in Chapter 18.79.

1. The following apply to signs placed in right-of-way (allowed for Political Signs, certain Special Event Signs, and Subdivision Directional Sign):
 - a. Right-of-way use permit may be required;
 - b. Signs shall not be placed so as to create a traffic hazard;
 - c. Signs shall not be placed in construction zones;
 - d. Signs shall not be placed in ADOT right-of-way, traffic medians, public sidewalks, or bicycle paths; and
 - e. Signs shall not be attached to any trees, fences, utility poles, street signs, or any other public facility located within the right-of-way.

2. Signs are limited to the number and size as specified below:

Construction sign: (STC 18.79.190 for additional regulations)

- Maximum of 2 signs and one per street frontage
- Maximum size: see zoning code

Human sign: (STC 18.79.280 for additional regulations)

- Maximum of 2 human signs per business
- Maximum of 20 square feet

Model Home Flag: (STC 18.79.330 for additional regulations)

- Maximum of 6 flags
- Maximum of 15 square feet

On-site subdivision sign: (STC 18.79.340 for additional regulations)

- Maximum of 2 signs
- Maximum size: see zoning code

Political Sign: (STC 18.79.350 for additional regulations)

- No limit to number of signs
- Maximum of 32 sq ft in commercial zones, 16 sq ft in all other zones

Real Estate Property Sign: (STC 18.79.370 for additional regulations)

- Maximum of 2 signs and one per street frontage
- Maximum size: see zoning code

Special event sign: (STC 18.79.400 for additional regulations)

- Maximum of 6 signs if offsite, 2 if on-site
- Maximum of 16 square feet if offsite, 60 square feet on-site

Subdivision directional sign: (STC 18.79.410)

- Maximum of 5 signs
- Maximum size: 6 square feet

3. Applicant shall remove all signs by the expiration date of this permit.
4. Applicant shall attach dimensioned drawings of each sign, along with a map or site plan showing all proposed locations.

I understand and agree to all of the conditions of the temporary sign permit. Violation of this agreement voids temporary sign approval.
