

## SAHUARITA ORDINANCE NO. 2025-187

---

AN ORDINANCE OF THE TOWN OF SAHUARITA, ARIZONA, AMENDING TITLE 3 (REVENUE AND FINANCE), CHAPTER 3.10 (FEE SCHEDULE), SECTION 3.10.140 (MISCELLANEOUS FEES) BY ADDING A NEW SUBSECTIONS H1 AND H2 (SOLID WASTE AND RECYCLING COLLECTION FEES), PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Town of Sahuarita, Arizona, as follows:

**Section 1.** The Town of Sahuarita Municipal Code Title 3 (Revenue and Finance), Chapter 3.10 (Fee Schedule), Section 3.10.140 (Miscellaneous Fees) is hereby amended by adding a new Subsections H2 and H3 (Solid Waste and Recycling Collection Fees) to read as follows:

### **3.10.140(H) Miscellaneous Fees**

	2.	Additional Waste Collection Cart	\$6.49 per month per cart
	3.	Service Reinstatement Fee	\$50.00 per reinstatement

**Section 2.** The various Town officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance and sections of the Town Code.

**Section 3.** All ordinances, resolutions, or motions and parts of ordinances, resolutions or motions of the Town Council in conflict with the provisions of this ordinance are hereby repealed, effective as of the date of this ordinance. All internal reference within the Town Code to any affected provision are hereby updated.

**Section 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance, or any part of this amendment to the Town Code, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

**Section 5.** The Town Clerk is hereby directed to publish this ordinance upon adoption as required by A.R.S. §§ 9-812 and 9-813.
