Mr. Marriotti provided an overview of the proposed tentative budget for Fiscal Year 2022, in the amount of \$1,040,910.00, and responded to questions from Council. Furthermore, Mr. Marriotti announced that a public hearing and final budget adoption were scheduled for the District Board meeting on May 24, 2021.




